Foreword

The Bundick name seems to have been indigenous to the Eastern Shore of Virginia in early records. It has been found only twice in records elsewhere. In April 1635, William Bundock or Bundick was master of the ship, Hopewell of London, bound for New England (Hooten, pp 44, 46, 49). Richard Hull gave Richard Bundick as one of his headrights, when he patented 300 acres on the north side of Mockjack Bay in Gloucester County, Virginia, on 13 August 1650 (Nugent I, p. 195). Since headrights could be collected before being used to patent land, it seems likely this was the same Richard Bundick who appeared in Eastern Shore records in 1647. No other record has been found of early Bundicks in other parts of Virginia. In local documents, the name has been spelled as: Bundock, Bunduck, Bunducke, Bundike, Blunducke, Bundic, and the 1810 Federal Census for Accomack County called all the men of this name Bundicks.

This is the third in a series, trying to tie together the Bundick families of Accomack County. The Metompkin line was completed in September 1993 and the Parksley line in February 1994. At least one other line will be traced, that of the Gargatha and Assawoman area. It appears there could be several families of unknowns, Bundicks who cannot be connected to either of these four lines.

Following this Bundick line has not proved difficult. Four of the men of the first five generations left wills, naming their sons, and the other had children named in the settling of his estate. The only oddity found was that usually there are several more generations in the period of years covered by this study. This can be explained by the line, at times, going through sons of a second marriage. Also, some of these Bundicks married late and were old enough to be the grandfathers of their children.

All documentation in the following write-up refers to Accomack County records unless otherwise noted. A list of these records, and secondary sources that have

been searched, is included at the end as references. It should be noted that until January 1, 1752, the 25th of March was New Year's Day. January, February and most of March before this had the same year date as the preceeding December. The dates of documents used herein have been changed to agree with the present calendar. It should also be noted that circa 1800 and before, "Senior" and "Junior" were often used as "the older" and "the younger" and did not necessarily refer to father and son.

Attention is called to John S. Bundick (1781-1861) of the fifth generation. He was earlier called John Bundick of Long, making it easier to distinguish between him and John S. Bundick (1785-1821), son of John Abbott Bundick of the Metompkin line.

In searching for the sons of John B. Bundick and their descendants, several local people have been contacted by telephone. I wish to thank Mrs. Polly Bundick Dize of Onancock, Mrs. Nora P. Bundick of Accomac, Mrs. James E. Bundick of Quinby, Mrs. Eldred P. Bundick of Quinby, and Mrs. J. Edward Bundick of Painter, for their help.

Richard Bundick, I
The First Generation

The name of Richard Bundick first appears in Eastern Shore of Virginia records on 30 August 1647, as his name was given with eight other headrights when John Foster patented 450 acres of land in Northampton County (North Co. Deeds, Wills 1645-1651, p. 110). The land was located on the sea side, between Nassawadox and Machipongo (Whitelaw, p. 365 and map). A colonist was eligible for 50 acres of land for each person for whom he had paid transportation costs from England. These persons were called headrights, and had agreed to work for their sponsor for several years, as indentured servants, to pay back their cost of transportation. However, Richard Bundick likely paid for his own passage and assigned his right to 50 acres to John Foster.

Richard Bundick made a deposition in Northampton County Court on 21 June 1662, in which he gave his age as 41 years "or thereabout" (North Co. Order Book 1657-1664, p. 97). This indicates he was born circa 1620 and was 27 years of age when he came to the Colony of Virginia.

He had married by 28 October 1648, for on that date Richard Bundick and Dorothy Bundick, his wife, signed a bond with their marks, agreeing to pay John Foster for the use of a "servant" (North Co. Deeds, Wills 1645-1651, p. 163). No record has been found of Dorothy Bundick's maiden name. It appears likely she was a widow and owned property when she married Richard Bundick. Dorothy Bundick died between 23 May 1663, when she cosigned a deed with her husband (Deeds and Wills 1663-1666, p. 10), and 16 November 1665, when Ruth was "ye wife of Richard Bundick" (p. 103). Ruth had had two children before she married Richard Bundick, John Jones and Thomas Jones. Accomack County records speak of them at times as Bundicks (Wills, Etc. 1673-1676, p. 242). They apparently left no local heirs, as they were living in Sussex County, Pennsylvania (Delaware) in 1685, when

they sold land in Accomack County (Deeds 1676-1690, p. 408). Ruth Bundick was still living in 1680, when she signed a last deed with her husband (Deeds 1676-1690, p. 236), but apparently died soon thereafter. Richard Bundick named his third wife as Elizabeth in his will of 1692.

Richard Bundick was granted a patent to 650 acres of land on the south side of Pungoteague Creek on 21 November 1654 (Nugent I, p. 296), a patent that was renewed on 20 October 1661 (p. 412). He sold this 650 acres on Pungoteague Creek to Francis Moryson on 6 September 1672 (North. Co. Deeds 1668-1680, p. 36). On 23 May 1663, Richard Bundick, planter, and wife Dorothy deeded 500 acres on the south side of Pungoteague Creek to Richard Jacob, deceased, saying this land had been purchased from Nicholas Waddelaw (Wallop) and that they had "received full and valluable satiffaction for ye afsd 500 acres" before Jacob died (Deeds and Wills 1663-1666, p. 9 and 10). Witnesses to the deed were Evitt Jones and Thomas ffowkes. Richard Jacob's will, written 13 January 1663, recorded 2 March 1663, apparently left this land to a son Issac and spoke, in his will, of 350 acres he was leaving son Thomas "at Pungoteague on the western part of a main branch of said Creek whereon Richard Bundick presently lives" (North. Co. Deeds, Will, etc. 1657-1666, p. 140).

On 12 July 1664, Richard Bundick was granted a patent for 1400 acres in Accomack County, "at seaboard side beginning at land of Col Edmund Scarburgh, bounded south by Long tone (Long Love) Branch" (Nugent I, p. 524). One of his headrights was a William Wright. On 9 October 1672, Richard Bundick patented 600 additional acres "Being the surplus within bounds of his 1400 acres at Arcadia" (Nugent II, p. 119). This block of circa 2000 acres is presently called Parkers Neck. It is bound south and west by Parkers Creek, the northern branch of which, called Long Love Branch or Poorhouse Branch, crosses U.S. 13 just south of Zion Church. The creek to the north was originally Arcadia Creek and on present-day

maps is labeled Bundicks Creek.

On 18 December 1666, Richard Bundick and Ruth, his wife, sold to Thomas ffowkes 700 acres "of Land being the one half of a patent of ffourteen hundred acres granted to me at James City under the hand of ye Hon^{ble} William Berkeley and sealed wth ye seale of ye Colony the 12 July 1664" (Deeds and Wills 1663-1666. p 39 and 40). The consideration was "8000 pounds of tobacco & Cast, the value thereof in hand". On 14 February 1667, Richard Bundick and wife Ruth gave his daughter, Elizabeth Sturgis, 200 acres "next unto ye lands sold to Mr. Thomas ffowkes" (p. 63). On 16 December 1673, Richard Bundick and Ruth sold 550 acres to John Drummond, stating this was all that could be found of his 9 October 1672 patent (Wills, Etc. 1673-1676, p. 104). On 16 November 1677 Richard Bundick and wife Ruth gave his son Richard 200 acres "next to my son in law John Sturgis - part of a 1400 acre Patent" (Wills & Deeds 1676-1690, p. 69). On 18 November 1680, Richard Bundick and wife Ruth sold to John Barns 300 acres for "tenn thousand ffour hundred pounds of good merchantable tobacco and cask - near Creek called by the name of Arcadia" (p. 236).

Richard Bundick lived to be an old man for the times. He would have been circa 72 when he wrote his will on 9 December 1692. It was recorded on 28 February 1693 (North. Co. Orders & Wills 1689-1698, p. 224). He owned no land at at this time and was apparently living in Northampton County. He called himself "Planter" and he named five children, each of whom was to receive 100 pounds of tobacco. His remaining estate, after debts were paid, was left to his wife Elizabeth and she was made executrix.

Richard Bundick's widow lived at least until 28 October 1698, when she made a gift of her entire estate to Mary Nottingham (North. Co. Deeds & Wills 1692-1707, p. 215). Mr. Whitlaw states (p. 329) that Mary Nottingham, wife of Richard Nottingham, Jr., "is said to have been born a Bundick". Since she was not named

by Richard Bundick in his will, it appears more likely Mary was a daughter of of Elizabeth Bundick by a former marriage to an unknown man.

The children of Richard Bundick, I, as named in his will, all apparently born of his first wife Dorothy, were:

1. Richard Bundick, II, born circa 1656. See next section.
2. Elizabeth Bundick, married by February 1667, John Sturgis. John Sturgis died testate in 1684 (Wills & Deeds 1676-1690, p. 385). Elizabeth then married Thomas Jones.
3. Ann Bundick, married Thomas Nixon.
4. Dorothy Bundick.
5. Grace Bundick.

Richard Bundick, son of Richard Bundick and his wife Dorothy, was born circa 1656. This birth year is based on his being 21 years old when his father deeded him Accomack County land in Parkers Neck in 1677. He would have married first circa 1680, but the name of this wife is unknown. He married secondly circa 1700, Susanna Justis, daughter of Ralph Justis and wife, Mary Abbott Justis. Ralph Justis had married circa 1675 (Justis booklet), so daughter Susanna was near the same age as Richard Bundick's oldest son George. Ralph Justis died testate in 1729, leaving property to Susanna Bundick's children when they "come to age or marry" (Wills 1729-1737, p. 47). He also named Abbott Bundick and Richard Bundick as grandsons and left them slaves.

On October 15 1691, Richard Bundick deeded John Barns the 300 acres his father had sold Barns in 1680, relinquishing any title he might have in the land (Wills & C Orders 1682-1697, p. 212). On 23 January 1689, Richard Bundick bought 200 acres "near the Seaboard" from Daniel Jenifer for 5600 pounds of good tobacco and cask, land to the north of "the Tann house branch" (Wills & Deeds 1676-1690, p. 491). On 10 December 1693, Richard Bundick bought another 74 acres from Daniel Jenifer, called Gargapha Savannah, for 2400 pounds of tobacco (Wills and Etc 1692-1715, part 1, p. 69). This land was near the last purchase. Richard Bundick purchased 299 acres near "Gilford Creek" for 5000 pounds of "Tobacco and Casq^{en}" from Edward Nixson, "Tanner" on 18 January 1701 (p. 394). He then owned 773 acres. The Quit Rents of Virginia in 1704 shows Richard Bundick of Accomack County, the only Bundick listed, as being taxed for 773 acres in that year (p. 14).

Richard Bundick, II, sold no land. He did give away two 100-acre tracts in May of 1728, one "near Guilford Branch", to daughter Susanna Onions and her

husband John Onions (Deeds Wills Etc 1715-1729, part 2, p. 206) and 100 acres near Gargatha to son Richard Bundick, Jun^r (same page).

Richard Bundick made his will on 23 May 1731 and it was recorded on 6 July of the same year (Deeds & Wills 1729-1739, part 1, p. 153). He left son George Bundick his home plantation of 200 acres and made him his executor. He gave son Abbott (under 21) 100 acres in the woods near Gargathy. He left 73 acres on Gargathy Branch to grandson, William Bundick Pearson. Son Justis Bundick (under 21) was to inherit 100 acres near Guilford. Son George was left the remainder of Richard's land "at the head of Guilford". He named five living daughters, three of whom were married, but no wife. It appears his second wife, Susanna Justis Bundick, was deceased before her father wrote his will in 1729. Richard Bundick, II, divided personal property between his children, but did ^{not} own slaves.

The children of Richard Bundick, II, as named in his will, were:

1. George Bundick, born circa 1680, died testate 1764 (Wills 1761-1767, p. 244).
2. Daughter Bundick, born circa 1682, married circa 1705, _____ Pearson.
3. Ann Bundick, born circa 1685, married _____ Abbott.
4. Susanna Bundick, born circa 1700, married John Onions.
5. Richard Bundick, III, born circa 1705. See next section.
6. Mary Bundick, born circa 1707, married Thomas Evans.
7. Abbott Bundick, born circa 1710, died testate 1784 (Wills 1784-1787, p. 48).
8. Tabitha Bundick, born circa 1712.
9. Keziah Bundick, born circa 1713.
10. Justis Bundick, born circa 1715, died testate 1769 (Wills 1767-1772, p. 252).

Richard Bundick, III
The Third Generation

Richard Bundick, III, son of Richard Bundick, II, and his second wife, Susanna Justis Bundick, was born circa 1705 in Parker's Neck, on land his father had been given in 1677 by the first Richard Bundick. On 7 May 1728, his father gave Richard Bundick, III, 100 acres near Gargatha, "part of land I bought of Colonel Jenefer" (Deeds, Wills & Etc 1715-1729, part 2, p. 206). When Richard Bundick, II, died testate in 1731, he only left son Richard 12 pence in his will, but he did mention that land he was leaving son Abbott Bundick adjoined son Richard's land. This Richard Bundick was also named in the 1728 will of his grandfather, Ralph Justis, who left him a slave (Wills & Deeds 1729-1737, part 1, p. 47).

Richard Bundick, III, would have married circa 1728. His wife was apparently Ann Nock, daughter of John Nock, who died testate in 1740, naming a daughter as Ann Bundick and making Richard Bundick one of his executors (Wills 1737-1743, p. 222).

Richard Bundick, III, lived his entire adult life on the 100 acres of land east of Gargatha that his father gave him in 1728. At his intestate death in 1766, the land descended to his oldest son, Richard Bundick, IV, called "Piper" in local records. Note that Whitelaw, p. 1160, has this 100 acres mixed up with the 72/74 acres Richard Bundick, II, left grandson William Bundick Pearson in 1731, apparently being unaware he had deeded this 100 acres to son Richard before he died. Mr. Whitelaw locates the land "at the present Gargatha on the highway, opposite the above Abbott Bundick land".

On 27 May 1766, John Bundick was named to administer the estate of Richard Bundick (Orders 1765-1767, p. 33). John would have been Richard's younger son and he gave his brother, Richard Bundick (Richard, IV, or "Piper"), as his security.

The inventory of Richard Bundick's personal estate, valued at 18 pounds 1 pence 19 shillings, was returned on 26 November 1766. It was signed by the appraisors: John Kittson, Charles Bagwell and William Nock (Wills 1761-1767, pp. 672 and 673).

It was divided into five lots, one for each of his children. They were:

1. A daughter who had married John Wimborough, likely Susanna, as John and Susanna Wimborough sold land in 1769 and 1771.
2. Ann Bundick, married _____ Holt.
3. A daughter who had married Edmund Mason.
4. Richard Bundick, IV, or Richard "Piper", born circa 1730, died testate 1790 (Wills 1788-1794, p. 306). See next section.
5. John Bundick, born circa 1732.

John Bundick, Long
The Fourth Generation

John Bundick, the second son of Richard Bundick, III, and his wife Ann Nock, was most likely named for his maternal grandfather, John Nock. He was born circa 1732 near Gargatha and raised on the land his father had been deeded in 1728 by Richard Bundick, II. As a younger son, John Bundick inherited no land from his father.

John Bundick would have been of age to have married by 1755. On 26 February 1763, John and Beershiba Bundick witnessed the will of Jonathan Bunting (Wills 1761-1767, p. 251). Jonathan Bunting owned land southwest of Accomac (Whitelaw, p. 899). Joseph Wimbrough wrote his will on 9 September 1767 and it was recorded on 29 January 1771 (Wills 1767-1772, p. 494). He named a daughter as Beersheba Bundick. Before the will was recorded, John Bundick, "who intermarried with one of the heirs of the decendent", was called into court "& having nothing to object the said will was admitted to probate". This shows John Bundick married (1) Beersheba Wimbrough, whose father Joseph owned land near Jonathan Bunting (Whitelaw, pp. 900 and 901).

John Bundick would have been circa 42 years of age in 1774, when he married (2) Sarah Foster, widow of James Foster and daughter of Thomas Whaley. On 29 March 1774, John Bundick, Junior, and Sarah his wife, "daughter and heir of Thomas Whaley", gave a deed of trust to Richard Bundick, Junior (his brother Richard, IV, or "Piper"), "for five shillings sterling of Great Britain" for 100 acres of land on Burton's Branch in the Parish of St. George. The said John and Sarah were to keep possession of the land during their lives (Deeds 1770-1777, p. 287). When Richard Bundick, IV, died in 1790, his will directed that his brother John Bundick have "the plantation where he now lives, which was conveyed to me by his wife Sarah, which was the widow of James Foster" (Wills 1788-1794, p. 306).

John Bundick was the first Bundick to live in St. George Parish, the southern parish of Accomack County. Apparently he lived southeast of Accomac on his father-in-law's land during his first marriage and moved to the land his second wife owned circa 1774. This land "on Burton's Branch" would have been between Melfa and Onley and east of U.S. 13.

John Bundick is shown in St. George Parish by the 1787 personal property tax list, when he was called "Long John". He was also on the 1788 tax list as "Long Jn^o". The 1800 Federal Census lists "John Bundick, Long" as over 45 years, still the only Bundick in St. George Parish. His household included two other males, one 10 to 16 years and the other 16 to 26 years. Two females were both 16 to 26 years old. Apparently he had lost his second wife by 1800.

John Bundick made his will on 4 October 1796 and it was recorded on 27 October 1800 (Wills 1800-1804, p. 342). He gave "unto my two Sons George Bundick and John Bundick all my lands and for it to be Equally Divided between them". If either should die without an heir then the other should have his half. If both George and John should die without heirs, the land was to go "unto my Grandson William Bundick Reed", then to grandson Laben Phillips. He loaned his wife Sarah his "Riding Chear" and after her death or marriage it was to go to his two sons. Daughter Nancy Phillips inherited "one Behive". Daughter Susanna Outten was loaned "all the Articles that She carried away which is one bed and furniture one Linen Wheel one Iron Pot" and these were to go to her son William Outten after her death. He gave son George "my shooting Gun" and son John "ten Dollars Cash to buy him a Gun". Grandson William Outten was to have five pounds for "Schooling". The remainder of his estate was to be divided between his wife Sarah and sons George and John. Wife Sarah and son George were to be executors.

On 7 July 1801, George Bundick and John Bundick deeded to John Shephard Ker and William Seymour, for 81 pounds 5 shillings, 100 acres "land devised by John

Bundick, dec^d, father of George and John". The land was bordered by lands of James Kellam, Benjamin Floyd, George Taylor and William Gibb (Deeds 1800-1804, p. 139). Both George and John were unmarried as no wives signed the deed. This was apparently a mortgage, as two other deeds followed. On 31 August 1802, George Bundick and wife Rachel sold to Littleton Ward 50 acres in St. George Parish for "100 pounds in gold and silver" (p. 364), land bound north by William Gibb, Sen^r, northeast by James Kellam, southeast by Benjamin Floyd, and southwest by Burton's Branch joining land of George Taylor. On 27 January 1803, John Bundick of John (unmarried) deeded to Littleton Ward 50 acres of land with the same boundries, for 100 pounds of gold and silver (p. 363).

The children of John Bundick, Long, his sons apparently by his second marriage, were:

1. George Bundick, born circa 1778, married (1) by bond of 23 March 1802, Rachel Mason. George Taylor, security (MLB 1774-1806, p. 6), (2) by bond of 11 June 1811, Elizabeth Kellam (MLB 1806-1832, p. 23). George Bundick's name has not been found in the 1810 census or that of 1820. He was apparently deceased by 11 September 1822, when Thomas H. Bradford mortgaged 100 acres to Elizabeth Bundick (Deeds 1829-1830, p. 27). The children of George Bundick are unknown, with the possible exception of a Samuel C. Bundick, who lived in the Locustville/Wachapreague area. Samuel was born circa 1805 (1850 census) and married by bond of 14 December 1836, Sally Bunting of Solomon (MLB 1832-1841, p. 5). He was a miller in 1860 and 1870 and had apparently died by 1880. His widow died 20 December 1892 (Reg. of Deaths). Samuel and Sally had three children: Elijah Thomas Bundick, born circa 1840; William S. Bundick, born circa 1844; and Sarah A./Sally Bundick, born circa 1847, married, 1867, Harry Groton (Mar. Reg. #3, p. 19).
2. John S. Bundick, born 1781. See next section.
3. A daughter who married _____ Reed.

4. Nancy Bundick, married _____ Phillips.

John Bundick of Long or John S. Bundick
The Fifth Generation

John Bundick, younger son of John Bundick and his wife, Sarah Whaley Foster Bundick, was born 4 May 1781 and died on 4 August 1861 at 80 years, 3 months (Reg. of Deaths). John Bundick of John, unmarried, sold the land he had inherited from his father in January 1803, when he would have been 22 years of age. His land joined that of George Taylor on the southwest.

John Bundick "(of Long)" married (1) by bond of 8 December 1808, Jane Taylor, widow of George Taylor (MLB 1806-1832, p. 23). Jane was a daughter of Zephaniah Bradford and wife Elizabeth. Her father owned 538 acres, land and marshes in the lower end of Bradford Neck, next to Upshur Neck and between Machipongo Creek and Upshur Bay. Jane inherited 92 acres of this land from her father in 1792 (Surveyor's Record #1, p. 205). Jane Bradford married (1) circa 1800, George Taylor. George Taylor of John died testate in 1804 (Wills 1804-1806, p. 206). He and his wife Jane had three children, but an only son, Charles Taylor, to whom he left his home land. George Taylor also left land to daughter Polly Taylor (1801-1886), who married John Belote (Chancery Orders 1856-1869, p. 279) and to daughter Sally Taylor, who married a Downing and was deceased by 1848.

John Bundick "(long)" bought 40 acres from Charles W. Taylor and wife Melinda on 31 December 1830 for \$225.29, part of George Taylor's land (Deeds 1830-1832, p. 62). John S. Bundick bought 54 acres, for \$530, from James R. Garrison on 7 December 1834 (Deeds 1834-1835, p. 312). John S. Bundick bought 50 acres, "part of Taylor land on which John S. Bundick now resides", for \$200 on 20 September 1848, the Sally Taylor Downing part (Deeds 1849-1851, p. 43). He bought 32 acres for \$270 from George W. Scott on 16 October 1848 (Deeds 1848-1849, p. 308). In June 1849, John S. Bundick bought 20 acres for \$240 from William B. Finney (Deeds 1848-1849, p. 602). He bought 20 additional acres from Louis C.H. Finney in November

1849 (Deeds 1849-1851, p. 111).

Jane Bundick, wife of John S. Bundick, died 28 April 1855 at 79 years 3 months 19 days (Reg. of Deaths). This places her birth in 1776, indicating she was five years older than her husband. On 18 March 1857, John S. Bundick, 77, "son of John and Sarah" married (2) Mary West, 64, a widow and the daughter of Laben Gunter and wife Sally, "at Crossroads" (Mar. Reg. #3, p. 6). On 15 July 1857, John S. Bundick deeded 23 acres for \$5.00 to his son John B. Bundick, land lying in Bradford Neck (Deeds 1855-1858, p. 485). His new wife did not cosign the deed. On 17 November 1858, John S. Bundick and wife Mary, "who was Mary West, widow of John" signed papers agreeing "to live separate and apart (Deeds 1858-1860, p. 275). The 1860 census shows John S. Bundick, at 79 years, living alone.

John S. Bundick made his will on 14 February 1861 and it was recorded on 26 August of the same year (Wills 1846-1882, p. 329). He gave his son John B. Bundick his Garrison land. He left his home farm to daughters Ann Mason and Susan Ward. His Scott and Finney lands were given to daughter Elizabeth "Dunckin". He left a slave named Mary to his son and gave money to his children and grandchildren.

John S. Bundick and his wife Jane were buried on his home farm, the Taylor land (Whitelaw, p. 848). Their stones stand in a family burial plot between Melfa and Onley, about one mile east of U.S. 13, with those of their daughters and their husbands (Graven Stones). Their children were:

1. John B. Bundick, born 1810. See next section.
2. Ann/Nancy Bundick, born 11 January 1814, died 13 June 1891, married by a bond of 9 September 1839, George W. Mason (MLB 1832-1841, p. 21).
3. Elizabeth Bundick, born 2 February 1816, died 7 August 1877, married 13 September 1843, John H. Duncan (Mar. Reg. #1, p. 72).
4. Susan J. Bundick, born 26 July 1819, died 13 January 1881, married 4 August 1858, John L. Ward (Mar. Reg. #3, p. 7).

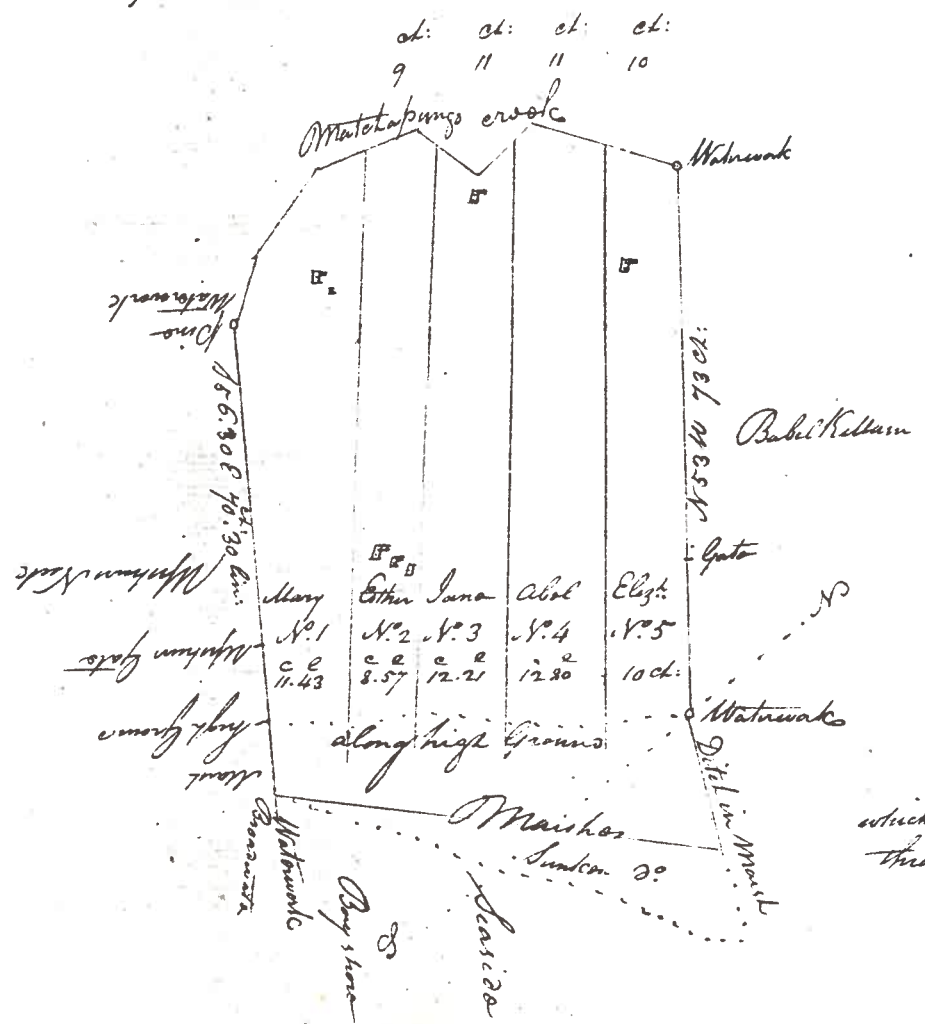

John B. Bundick
The Sixth Generation

John B. Bundick, the only son of John S. Bundick and wife Jane Bradford Taylor Bundick, was born on 19 January 1810 and died on 28 May 1888, according to his tombstone in a family plot called "Old Homestead", slightly north of present-day Quinby (Graven Stones, p. 40). His wife's stone there states: Margaret E. Bundick, nee Floyd, died 1 June 1883 aged 55 years 8 months 8 days (p. 41). John B. Bundick married Margaret E. Floyd on 8 April 1846 (Mar. Reg. #2, p. 47), when he would have been 36 years of age and his bride 18 years old.

On 27 July 1847, John B. Bundick bought, for \$825, from Thomas F. Floyd and wife Margaret E., their interest in 67 acres (Deeds 1846-1848, p. 523). This land was bordered west by Matchapungo Creek east by "the Broadwater" (present Upshurs Bay), north by Joshua Burton and south by Elizabeth Barnes' land. The deed of 1857, to John B. Bundick from his father, for 23 acres in Bradford Neck, gives the same boundries on the east and west. On 17 May 1866, John B. Bundick bought at public auction 96 acres for \$2400 (Deeds 1865-1867, p. 474), land bordered on the west by Matchapungo Creek, east by Broadwater, and south by Nathaniel Lecato. He then owned 186 acres in Bradford Neck, between Wachapreague and Quinby, and his land appears to have been the land his mother Jane inherited from her father, Zephaniah Bradford, in 1790 and that of his uncle Abel Bradford (Whitelaw, pp. 771 and 772).

John B. Bundick sold 54 acres to Francis S. Smith on 27 March 1885, for \$1230 (Deeds 1884-1885, p. 327). This was apparently the Garrison land he inherited from his father.

The 1850 Federal Census shows John B. Bundick at 40 years, a farmer, in household 933 in St. George Parish. His wife, Margaret E., was 23. Their household included three children: William at 3 years, Mary J. a 1-year-old, and

Elizabeth S. of 2 months. By 1860, there were five other children: Susan at 7 years, John F. at 5 years, Charles B. at 4 years, James E. at 2 years and Margaret R. at 7 months. In 1870, John B. Bundick was 60 years of age and still farming. His older son was no longer in his household but there were three additional children: Amanda A. at 9 years, Fluranna J. at 7 years and George E. L. at 3 years. The 1880 census lists John B. Bundick, a 70-year-old farmer, in household 207/237 of Pungoteague District. His wife Margaret E. Bundick was 52 and eight of their children were living at home, the youngest being George E. at 13 years.

George W. LeCato was named to administer the estate of John B. Bundick on 25 June 1888 (Orders 1886-1889, p. 552). On 31 July 1888, the children of John B. Bundick "lately deceased", deeded to George W. LeCato, Trustee, the land they inherited from their father in Bradford's Neck, three tracts bound northwest by Machipongo Creek, southeast by Upshur's Broadwater, northeast by George W. James and southwest by the heirs of William LeCato, deceased (Deeds 60, p. 31). George W. LeCato, Trustee, sold lot #3 to John T. Powell, on 25 October 1888, as 61 acres for \$700 (Deeds 60, p. 230). He sold lot #2 to Benjamin T. Eichelberger on the same date, 67 acres for \$1,406 (Deeds 60, p. 234). On 18 November 1889, George W. LeCato, trustee of the estate of John B. Bundick, sold lot #1, 23 acres, to Charles B. Bundick for \$655 (Deeds 67, p. 503). Charles B. Bundick and wife Virgie B. sold this 23 acres, "land near Quinby in Bradford's Neck" to James A. Eichelberger on 17 June 1911 for \$1250 (Deeds 97, p. 363).

The obituary of John B. Bundick appeared in the June 2, 1888 issue of The Peninsula Enterprise under Wachapreague news. It states he was of Bradford's Neck and left 11 children. His wife's obituary appeared in the June 7, 1883 issue under Savageville news. It states she was "formerly of this locality but of late a resident of Bradford's Neck". She died of paralysis. Their children were:

1. William Thomas Bundick, born 15 February 1847. See next section.

2. Mary J. Bundick, born circa 1849 (1850 census), married (1) 29 November 1871, Elijah Sturgis (Mar. Reg. #3, p. 32), (2) 17 October 1880, James S. Sturgis (Mar. Reg. #3, p. 64).
3. Elizabeth J. Bundick, born 1850 (1850 census), aged 30 years and unmarried in 1880.
4. Margaret Matilda Bundick, daughter of John B. and Margaret, died 11 June 1852 at 11 months (Reg. of Deaths).
5. Susan A. Bundick, born circa 1853 (1860 census), married 24 October 1875, John ^{A.} Eichelberger (Mar. Reg. #3, p. 44).
6. John F. Bundick, born 7 August 1854. See next section.
7. Charles B. Bundick, born circa 1856 (1860 census). See next section.
8. James Eldred Bundick, born 1858. See next section.
9. Margaret R./Maggie Bundick, born 11 October 1859, died 28 March 1925 (Graven Stones, p. 270), married 7 May 1891, Joseph C. Watson (Mar. Reg. #3, p. 111).
10. Amanda A. Bundick, born 11 May 1862, died 18 August 1914 (Graven Stones, p. 36), married (1) 7 December 1882, Robert Willis (Mar. Reg. #3, p. 74), (2) 3 December 1890, Henry Lee Bull (Mar. Reg. #3, p. 108).
11. Fluranna J. Bundick, born circa 1863 (1870 census), married (1) 17 November 1880, John Abner Goffigon (Mar. Reg. #3, p. 64), (2) 29 November 1911, Horace S. Lane (Mar. Reg. #4, p. 184).
12. Emer J. Bundick, daughter of John B. and Margaret, died 5 September 1865 (Reg. of Deaths).
13. George Everett Bundick, born 10 January 1867. See next section.

Sons of John B. Bundick
The Seventh Generation

William Thomas Bundick, born 15 February 1847, died 4 December 1908 (Graven Stones, p. 41), married 8 January 1868, Catherine D. Ames (Mar. Reg. #3, p 22). His wife was born 15 August 1849 and died 10 March 1915 (Graven Stones, p. 40). William T. Bundick was a merchant in Onancock until circa 1890, when he became a temperance lecturer. Not only did he give local and state speeches on the evils of alcohol, but became nationally known. He published a book in 1904, giving some of his speeches (Press of Jennings & Graham, Cincinnati). He had then toured sixteen states and the District of Columbia, giving lectures in over 2,755 churches. His obituary states that "his last continued engagement was in Nebraska during the past summer" (Pen. Ent., 12 December 1908 issue). He and his wife are buried in Onancock Cemetery. They had five children:

1. Margaret S./Maggie S. Bundick, born 23 February 1869, died 22 January 1918 (Graven Stones, p 250), married 22 November 1887, William M. Taylor, Jr. (Mar. Reg. #3, p. 94). They are buried in Hacks Neck.

2. Mary N. Bundick, born 31 October 1871, died 13 February 1922 (Graven Stones, p. 254), married 1 November 1892, George S. Tignal (Mar. Reg. #3, p. 117). They are buried in Onancock Cemetery.

3. John T. Bundick, born 1873, died 1925 (Graven Stones, p. 40), married 24 March 1893, Eva May Downing (Mar. Reg #4, p. 14). They were buried in Onancock Cemetery. This couple had two children: Evelyn Bundick, who married Tom Bell and lived in Richmond and John William "Bill" Bundick, born 27 January 1904, died 11 May 1950, at 46 years (Obituary in 19 May 1950 issue, Pen. Ent.), married Hamner Dunkley (1903-1977). They had an only daughter, Polly Bundick, who is now the widow of Coleburn Dize. Bill Bundick was a merchant in Onancock until 1936. He and Charles D. Johnson bought the J.T. Lilliston undertaking business in 1933 and

operated as Bundick & Johnson Funeral Directors in Onancock until 1949, when they sold the business to Carlisle Williams.

4. Catherine Maude Bundick, born 1875, died 1956 (Graven Stones, p. 234), married 21 April 1897, Alfred Thomas Tignal (Mar. Reg. #4, p. 14). He was a brother of George S. Tignal. They, too, were buried in Onancock Cemetery.

5. Clyde W. Bundick, son of William T. and Kate S., died 10 September 1881 at 1 year 4 months 19 days (Reg. of Deaths).

John F. Bundick, born 7 August 1854, died 4 April 1904 (Graven Stones, p. 40), married 6 May 1879, Elizabeth L. Ayres (Mar. Reg. #3, p. 58). His wife was born 4 July 1854 and died 8 March 1936. This family was living at Mappsburg when he died and his widow lived in Painter (Obituary of John F. Bundick in Pen. Ent., 9 April 1904 issue and that of Mrs. Bettie L. Bundick in 14 March 1936 issue). They were buried in the "family burying ground in Bradford's Neck". Their children were:

1. John Edward Bundick, born January 1880 (1900 census). E. J. Bundick was of Richmond when his mother died in 1936.

2. Benjamin R. Bundick, son of John and Bettie, was born 30 June 1881 and died 13 October 1882 (Graven Stones, p. 39).

3. Charles Jacob Bundick, born March 1882 (1900 census). Tombstones in Belle Haven Cemetery read: Charlie J. Bundick, born 1882, died 1961, and Lizzie S. Bundick, born 1883, died 1958 (Gravestone Inscriptions of Northampton County, p. 13). They had a daughter, Fairy M., born circa 1906 (1910 census) and a son, John Edward Bundick of Painter, born circa 1911 (1920 census).

4. Margaret S. Bundick, born January 1886 (1900 census). Maggie S. Bundick married 27 July 1904, Phillip Brooks Mason, in Worcester County, MD (LES Maryland Mar. 1865-1906, p. 60). They were living at Poquoson, VA, in 1936, when her mother died in their home there.

5. Benjamin F. Bundick, born October 1890 (1900 census). Floyd Bundick was of Newport News, when his mother died in 1936.

6. William T. Bundick, born 11 October 1893, died 15 January 1914 (Graven Stones, p. 41). William T. Bundick, "a very worthy young man of Painter, VA, aged twenty-one years, was killed in the employ of a R.R. company in Baltimore" (Pen. Ent., 24 January 1914 issue). He was buried in the family plot at Quinby.

Charles B. Bundick, born March 1857 (1900 census). Charles B. Bundick married Virginia B. Lane on 2 August 1899 (Mar. Reg. #4, p 40). The 1910 census shows Charles B. Bundick at 53 years of age. His wife, Virginia B., was then 29 and they had two children: Charles L. Bundick of 9 years and Elizabeth M. Bundick at 3 years. After Charles B. Bundick and his wife sold the last of his father's land in Bradford Neck in 1911 nothing more has been found of the family in Accomack County. They were living in Delmar, Delaware, in 1925, when his sister, Maggie Watson, died (Pen. Ent., 4 April 1925 issue).

James Eldred Bundick, born 1858, died 1944 (Graven Stones, p. 40), married 13 December 1883, Manie E. Mears (Mar. Reg. #3, p. 78). His wife, called Mary Ellen Bundick on her tombstone, was born in 1863 and died in 1939 (Graven Stones, p. 41). They were buried at Wachapreague. His obituary states he spent most of his life at Quinby, but died on 26 January 1944 at the home of his daughter at Shields, at 86 years 11 months 19 days (Pen. Ent., 28 January 1944 issue). There were four children:

1. Nellie C./Constance Bundick, born 30 October 1884 (Reg. of Births), married 18 December 1908, A.C. Duer, Jr. (Mar. Reg. #4, p. 140).

2. John T. Bundick, born 14 May 1886 (Reg. of Births). Tombstones in Quinby Cemetery read: John T. Bundick, born 1886, died 1953, and wife, Annie B. Bundick, born 1890, died 1971 (Graven Stones, pp. 39 and 40). John T. Bundick married 22

December 1909, Annie Mildred Bell (Mar. Reg. #4, p. 164). The 1920 census shows this family with four children: John B. (Brandon) at 9 years, Eldred Putman at 5 years, James E. at 2 years 3 months and Annie M. at 2 years 3 months. Son James E. was the father of Jimmy Bundick of Bundick's Well & Pump Co., Painter.

3. Robert E. Bundick, born 28 January 1891, died 23 February 1920, buried Edgehill Cemetery, Accomac (Graven Stones, p. 41), married 29 November 1914, Susie E. Savage (Mar. Reg. #4, p. 218). This couple had an only son, Robert Felix Bundick, who married Nora Frances Parker and lives in Accomac.

4. Byron Lee Bundick, born circa 1895 (1910 census). Byron Lee Bundick, 33, married Mildred Elizabeth Harmon, 26, at Hallwood, on 20 November 1927. He was a railroad clerk from Belle Haven, son of James E. and Mary E. Bundick. She was from Melfa, daughter of John E. and Evelyn Harmon (Mar. Reg. #5, p. 10). This family was of Washington, D.C., when his father died in 1944.

George Everett Bundick, born 10 January 1867 (Reg. of Births), died 28 April 1952 at 85 years (Obituary in Pen. Ent., 1 May 1952 issue), married 12 December 1888, Ocea E. Colona, in Worcester County, MD (LES Maryland, Mar. 1865-1906, p. 60). Mrs. Ocea Colona Bundick died at her home in Keller on 22 October 1946, aged 73 years, and was buried in Mt. Holly Cemetery, Onancock. She was the daughter of Sarah Wallace and John E. Colona (Pen. Ent., 25 October 1945 issue). They had five children:

1. Gertrude S. Bundick, born 20 July 1890, died 4 January 1936, according to her tombstone in Hollies Church Cemetery, Keller (Graven Stones, p. 203), married 9 February 1910, Augustus W. Phillips (Mar. Reg. #4, p. 166).

2. Arthur Page Bundick, born 13 May 1893 (1900 census), married 24 January 1916, Gertrude F. Kellam (Mar. Reg. #4 p. 234). This family was of Wildwood, New Jersey, in 1946, when his mother died.

3. Lottie O. Bundick, born 19 July 1896 (1900 census). No local marriage has been found, but Mrs. Lottie O. McBride was also of Wildwood, New Jersey, when her mother died in 1946. Tombstones in Mt. Holly Cemetery, Onancock, read: John F. McBride, born 1891, died 1955, and Lottie B. McBride, wife of John F., born 1896, died - (Graven Stones, p. 158).

4. George Addison Bundick, born circa 1899 (1910 census), was of Keller in 1946, when he was listed as a son of Mrs. George E. Bundick. When his father died in 1952, son George Addison Bundick was of Lester, Pennsylvania. No local record of his marriage has been found. It is doubtful that he married, as a tombstone in Mt. Holly Cemetery states: George A. Bundick, born 1908, died 25 June 1976 (Graven Stones, p. 40).

5. William T. Bundick, born circa 1908 (1910 census). no other record. Likely died young.

Note: The 1910 census apparently has the last two sons of George E. Bundick mixed up. Neither are listed by the 1900 census.
